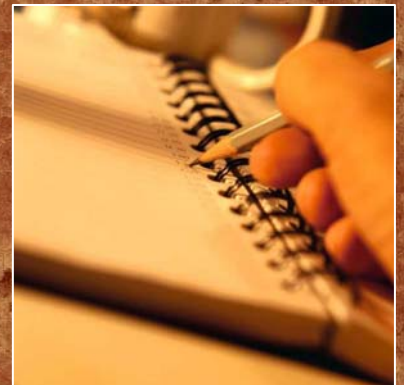
HEADING INTO 2007
